

Is Your Application Complete?

To ensure that there are no unwarranted delays in the processing of your application this checklist is provided to ensure that you have included all necessary details and attachments.

All Parties

- Have you included the name of the party exactly as you want it to appear in the Register?
- If you wish to enter an abbreviation of the party name have you included it in the application?
- Have you given the party's postal address?
- Have you indicated whether the party wishes to receive election funding?
- Have you given the name of the person who is to be the registered officer of the party and an address which is NOT a post office box?
- Has the person who is to be the registered officer signed the form?
- Have you attached a copy of the party's constitution?
- Have you included the \$500 application fee?

Parliamentary Party

- If the application is being made by the party secretary, have you included a letter from all the party's parliamentary members, OR if the application is being made by the party's parliamentary members have they all signed the application?
- Have you attached a Statutory Declaration from the secretary of the party affirming that the parliamentary members are accepted as members of the party?

Non-parliamentary Party

- Is the application signed by 10 members of the party who are entitled to be enrolled and have they included an address which is not a PO Box?
- Have you attached at least 500 membership application forms as described in the handbook?
- (The first 10 forms should be those of the 10 people making the application for registration.)
- Have you provided a membership list?
- Have you attached a Statutory Declaration from the secretary of the party attesting to those membership declarations?

Branch/Division of a federally registered political party

- Have you attached a letter from the registered party, signed by the secretary of that party, confirming your party's status?
