An Act

To amend the Rodrigues Regional Assembly Act 2001

ENACTED by the Parliament of Mauritius, as follows -

### 1. Short title

This Act may be cited as the Rodrigues Regional Assembly (Amendment No. 2) Act 2002.

#### 2. Interpretation

In this Act -

"principal Act" means the Rodrigues Regional Assembly Act 2001.

## 3. Section 14 of principal Act amended

Section 14 of the principal Act is amended by deleting the words "the Chairperson or the Deputy Chairperson shall administer the oath of office set out in the Third Schedule" and replacing them by

the words "the President or the Vice President shall, in accordance with the provisions of section 34, administer the oath of office set out in the Third Schedule".

## 4. Section 66 of principal Act amended

Section 66 of the principal Act is amended by adding after subsection (3), the following new subsection -

(4) Any reference to the Island Secretary in any enactment shall be construed as a reference to the Island Chief Executive.

## 5. Section 71 of principal Act amended

Section 71 of the principal Act is amended by adding after subsection (4), the following new subsection -

(5) Nothing in this section shall be construe as preventing the Secretary to Cabinet and Head of the Civil

Service and the Island Chief Executive from agreeing to an officer on the Civil Establishment of the Island of Mauritius serving on a tour of service in Rodrigues.

### 6. New Part VIA added to principal Act

The principal Act is amended by inserting immediately after section 71, the following new Part -

### PART VIA - POWERS OF THE PRESIDENT

### 71A. Powers of the President

The President may -

- (a) by Proclamation, fix the place, date and time at which the Regional Assembly shall meet for the purposes of sections 12, 13, 14 and 56;
- (b) make such regulations as he thinks fit for the purposes of this Act, and

(c) address the Regional Assembly at the sitting specified in section 12 or any ordinary meeting of the Regional Assembly.

# 7. Fourth Schedule to principal Act amended

The Fourth Schedule to the principal Act is amended in item (48), by deleting the word "Chairperson" and replacing it by the word President".
