# AMENDMENT OF REGULATIONS FOR REGISTRATION OF VOTERS AND POLITICAL PARTIES

The Electoral Commission has, under section 130 of the Electoral Act, 1992 (Act 24 of 1992), made the regulations set out in the Schedule.

## SCHEDULE

- 1. In the Schedule "the Regulations" means the regulations published by Government Notice 128 of 1992.
- 2. The Regulations are hereby amended by the deletion of the expression "polling district" wherever it occurs.
