STATUTORY DECLARATION OF A PERSON
NOMINATED AS A CANDIDATE FOR
PARLIAMENT

(Regulation 6a)

I,..... do solemnly and sincerely declare that

1. I am a citizen of Ghana

2. I have attained the age of twenty-one years

3. I am a registered voter

4. I do not owe allegiance to any country other than Ghana

5. (i) I am resident in constituency
for which I can stand as a candidate for election to Parliament; or

(ii) I have resided in constituency for a total period of not less
than five years out of the ten years immediately preceding the elections for which I am standing; or

(iii) I hail from constituency. *(delete where inapplicable)*

6. (i) I have paid all my taxes; or

(ii) I have made arrangements satisfactory to the appropriate authority for the payment of my taxes *(delete where inapplicable)*.

7. I have not been adjudged or otherwise declared

(i) bankrupt under any law in force in Ghana from which I have not been discharged; or

(ii) to be of unsound mind or detained as a criminal lunatic under any law in force in Ghana.

8. (a) I have not been convicted-

(i) for treason or for an offence involving the security of the State, fraud, dishonesty or moral turpitude; or

(ii) for any other offence punishable by death or a sentence of ten years or more; or

(iii) for an offence relating to or connected with election under a law in force in Ghana at any time; I

(b) I have been convicted for (indicate the offence specified in 8 (a))

but ten years or more have passed since the conviction, or I have been pardoned *(delete where inapplicable)*.

9. (a) I have not been found by a report of a commission or committee of inquiry to be incompetent to hold public office. I am not a person in respect of whom a commission or a committee of inquiry has found that while being public officer, I acquired assets unlawfully, or defrauded the state, or misused or abused my office, or wilfully acted in a manner prejudicial to the interest of the state and such findings have not been set aside on appeal, or judicial review.
- (b) I have been disqualified to stand for election by a report of a committee of inquiry but ten years or more have passed since the date of disqualification (~~delete~~ where *inapplicable*).
10. I am not under sentence of death, or other sentence of imprisonment imposed on me by any court.
11. I am not disqualified to be registered as a voter under the provisions of any law relating to public elections.
12. I am not disqualified for election by any law in force in Ghana by reason of my holding or acting in any office, the functions of which involve a responsibility for or in connection with the conduct of an election or any responsibility for the compilation or revision of any electoral register.
13. I am not a member of the Police Service; the Prisons Service; the Armed Forces; the Judicial Service; the Civil Service; the Audit Service; the Fire Service, the Legal Service; the Parliamentary Service; the Statistical Service; the Custom, Excise and Preventive Service; the Immigration Service or the Internal Revenue Service.
14. I am not a chief
15. I am not otherwise disqualified from standing for election by any law in force in Ghana.
16. I have declared my assets in accordance with P.N.D.C.L. 2S0
