I am not a person in respect of whom a commission or a committee of inquiry has found that while being public officer, I acquired assets unlawfully, or defrauded the state, or misused or abused my office, or wilfully acted in a manner prejudicial to the interest of the state and such findings have not been set aside on appeal, orjudicial review.
 - (b) I have been disqualified to stand for election by a report of a committee of enquiry but ten years or more have passed since the date of disqualification (delete where *inapplicable*).
- 10. I am not under sentence of death, or other sentence of imprisonment imposed on me by any court.
- 11. I am not disqualified to be registered as a voter under the provisions of any law relating to public elections.
- 12. I am not disqualified for election by any law in force in Ghana by reason of my holding or acting in any office, the functions of which involve a responsibility for or in connection with the conduct of an election or any responsibility for the compilation or revision of any electoral register.
- 13. I am not a member of the Police Service; the Prisons Service; the Armed Forces; the Judicial Service; the Civil Service; the Audit Service; the Fire Service, the Legal Service; the Parliamentary Service; the Statistical Service; the Custom, Excise and Preventive Service; the Immigration Service or the Internal Revenue Service.
